The Monash/C2Zero Real Carbon Price Index (RCPI) provides a weighted composite measure of the physical price of carbon¹ across all jurisdictions, based on mandated carbon prices set by regulators and governments.

The RCPI covers national, subnational and regional jurisdictions implementing a carbon tax or carbon emissions trading schemes (ETS) ²and jurisdictions with no mandatory carbon price – the latter being counted in the index using a price of zero.

The RCPI enables an overall global carbon price and price history to be determined, reflecting the global value of carbon, as priced across all jurisdictions, dating back to April 2013.


The RCPI started in April 2013, covering 20 jurisdictions, accounting for 7.88% of global GHG emissions. As of June 2022, it covered 58 jurisdictions, accounting for 22.5% of global GHG emissions.

Highlights

(April 2013- November 2022)



- In November, the global carbon price continuously rebounded by 6.05%.
- The EU ETS experienced a second consecutive monthly increase with prices reaching their highest level since late August as a result of increased buying interest, with the USD decreasing vs. the EUR also contributing to the increase.
- The total volume traded in the second largest ETS – China National ETS, reached 200mil CEAs in November, since its launch in July 2021.
- The third largest ETS Korea ETS, plunged by 19%, even though South Korea outlined a number of changes to improve the effectiveness of its emission trading scheme.




