# Monash/C2Zero Real Carbon Price Index

#### Fact sheet | 29 February 2024

The Monash/C2Zero Real Carbon Price Index (RCPI) provides a weighted composite measure of the physical price of carbon<sup>1</sup> across all jurisdictions based on mandated carbon prices set by regulators and governments.


The RCPI covers national, subnational and regional jurisdictions implementing a carbon tax or carbon emissions trading schemes (ETS) <sup>2</sup>and jurisdictions with no mandatory carbon price – the latter being counted in the index using a price of zero.

The RCPI enables an overall global carbon price and price history to be determined, reflecting the global value of carbon.

The RCPI started in April 2013, covering 20 jurisdictions, accounting for 7.88% of global GHG emissions. As of June 2023, it covered 58 jurisdictions, accounting for 22.59% of global GHG emissions.

# Highlights

- The Global carbon pricing maintained its downward trend, concluding February with a slight decrease.
- The EU ETS reached a 31-month low since June 2021, attributed to weak market sentiment.
- Conversely, the China National ETS experienced a surge to a four-month peak on the final day of February, following a month characterized by low trading volumes and sluggish demand. Notably, on February 5, China implemented new regulations designed to reinforce its national ETS.




